WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON PETITION FOR DECLARATORY RULING FILED BY CTIA REGARDING WHETHER EARLY TERMINATION FEES ARE "RATES CHARGED" WITHIN 47 U.S.C. SECTION 332(c)(3)(A)

On March 15, 2005, the Cellular Telecommunications & Internet Association ("CTIA") filed a Petition for Expedited Declaratory Ruling ("CTIA Petition"), seeking a declaratory ruling by the Commission that early termination fees in wireless carriers' service contracts are "rates charged" for CMRS within the meaning of Section 332(c)(3)(A) of the Communications Act and Commission precedent. CTIA also seeks a declaration from the Commission that any application of state law by a court or other tribunal to invalidate, modify, or condition the use or enforcement of early termination fees based, in whole or in part, upon an assessment of reasonableness, fairness, or costbasis of the early termination fee, or to prohibit the use of early termination fees as unlawful liquidated damages or penalties, constitutes prohibited rate regulation preempted by Section 332(c)(3)(A). The CTIA Petition raises important issues, and in this Public Notice, we seek comment on the Petition.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments in this proceeding on or before the 30th day after publication of this Public Notice in the Federal Register, and reply comments may be filed on or before the 50th day after publication of this Public Notice in the Federal Register. When filing comments, please reference WT Docket No. 05-194. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg. 24121 (1998).
