COMMENTS INVITED ON APPLICATION OF SPRINT COMMUNICATIONS COMPANY LP TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

WC Docket No. 05-197

Section 214 Application

Applicant: Sprint Communications Company LP

On **May 17, 2005**, **Sprint Communications Company LP** (Sprint or Applicant), located at **6360 Sprint Parkway, Overland Park, Kansas 66251**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of local service to both residential and business customers located in Gaithersburg, Maryland.

Sprint indicates that it provides local service to approximately 81 business and residential customers served by the Gaithersburg wire center of Verizon Maryland Inc. Sprint states that it currently provides local service to these customers using the Unbundled Network Element-Platform (UNE-P) offering of Verizon. Sprint indicates, however, that Verizon will discontinue offering UNE-P upon conversion of its Gaithersburg wire center switch from circuit to packet later this year. Sprint states that it has determined it would be more cost effective to discontinue offering local service to these customers rather than migrate them to an alternative local service arrangement. Sprint indicates that, on or about May 10, 2005, it sent letters to all of its affected customers advising them that they should select a new local carrier by June 10, 2005 in order to avoid losing service on June 17, 2005, or as soon thereafter as practical for the discontinuance of Sprint's service. Sprint adds that it plans to end its provision of local service no later than July 1, 2005. Sprint indicates that it is considered non-dominant with respect to the service it seeks to discontinue.

In accordance with section 63.71(c) of the Commission's rules, Sprint's application will be deemed to be automatically granted on the thirty-first (31st) day after the release date of this public notice, unless the Commission notifies Sprint that the grant will not be automatically effective. Accordingly, pursuant to section 63.71(c), absent further Commission action, Sprint may not terminate service to the customers affected by this application until **June 26, 2005**. The Commission will normally

authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **June 9, 2005**. Such comments should refer to **WC Docket No. 05-197 and Comp. Pol. File No. 714**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send e-mail to ecfs@fcc.gov, and should include the following words in the subject line “get form <your e-mail address>.” A sample form and directions will be sent in reply.
