**COMMENT AND REPLY COMMENT DATES ESTABLISHED FOR  
NOTICE OF PROPOSED RULEMAKING IN THE MATTER OF  
E911 REQUIREMENTS FOR IP-ENABLED SERVICE PROVIDERS**

**WC DOCKET NO. 05-196**

**Comments Due: August 15, 2005**  
**Reply Comments Due: September 12, 2005**

On June 3, 2005, the Commission released the *Notice of Proposed Rulemaking* in WC Docket No. 05-196 (*NPRM*).<sup>1</sup> In the *NPRM*, the Commission sought comment on what additional steps it should take to ensure that providers of VoIP services that interconnect with the nation's PSTN provide ubiquitous and reliable E911 service. A summary of the *NPRM* was published in the Federal Register on June 29, 2005, triggering the cycle for comments and reply comments.<sup>2</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented is generally required. Other requirements pertaining to oral and written presentations are set forth in section 1.1206(b) of the Commission's rules.<sup>3</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R §§ 1.415, 1.419, interested parties may file comments on or before August 15, 2005 and reply comments on or before

June 3, 2005). Together with the *NPRM*, the Commission adopted the *First Report and Order* in WC Docket No. 04-36 (*Order*). In the *Order*, the Commission established rules requiring providers of interconnected voice over Internet Protocol (VoIP) – meaning VoIP service that allows a user generally to receive calls originating from and to terminate calls to the public switched telephone network (PSTN) – to provide enhanced 911 (E911) capabilities to their customers as a standard feature of the service, rather than as an optional enhancement. *See id.* As discussed in the *Order*, the effective date for the new information collection requirements set forth in the *Order* is subject to Office of Management and Budget (OMB) approval. *See id.* at para. 73. The Commission has requested OMB approval on an expedited basis pursuant to emergency request. *See* 70 Fed. Reg. 37,403 (June 29, 2005). The Commission will release an additional Public Notice announcing OMB's disposition of the Commission's emergency request.

September 12, 2005. All filings related to this *NPRM* should refer to WC Docket No. 05-196. The Commission has incorporated the comments and *ex parte* presentations in WC Docket No. 04-36 into WC Docket No. 05-196. Commenters need not resubmit material previously filed in WC Docket No. 04-36. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See* Electronic Filing of Documents in Rulemaking Proceedings, 63 FR 24121 (1998).

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
