## **PUBLIC DEMONSTRATION OF NEW FILING PROCESS FOR FCC FORM 603 FOR ASSIGNMENTS OF AUTHORIZATION AND TRANSFERS OF CONTROL IN THE UNIVERSAL LICENSING SYSTEM WILL TAKE PLACE ON JULY 19, 2005**

On August 1, 2005, the FCC Wireless Telecommunications Bureau (WTB) will deploy a revised form and new filing interface for electronic filing of FCC Form 603, FCC Wireless Telecommunications Bureau Application for Assignments of Authorization and Transfers of Control. The WTB will hold a demonstration and training session on how to file applications in the redesigned interface on Tuesday, July 19, 2005, from 1–3 p.m. The event will take place in the South Conference Room (Room 6-B516), on the Sixth Floor of the Portals II building, at the Commission's Washington, DC headquarters, 445 Twelfth Street, SW. Interested parties are required to pre-register for the event by July 18, 2005.

### **Demonstration of New Filing Process for Revised FCC Form 603**

FCC Form 603 has been revised in order to, among other things, implement the Commission's recently adopted policies in its Secondary Markets proceeding regarding the immediate approval of certain license Assignments of Authorization and Transfers of Control.<sup>1</sup> In addition, the revised Form 603 will be filed in a new interface: ULS License Manager. License Manager provides an enhanced filing environment<sup>2</sup> for working with wireless applications and allows for simplified filing of applications in question and answer format through an application wizard.<sup>3</sup> The demonstration and training session will include the following:

- Demonstration of how to file Assignments of Authorization and Transfers of Control in the new environment; and
- An opportunity for attendees to ask questions.

An overview of key changes to Form 603 and the filing process will be provided in a separate public notice announcing the deployment of the form in ULS.
