**COMMENTS INVITED ON SOUTHERN CALIFORNIA (REGION 5)  
PUBLIC SAFETY PLAN AMENDMENT  
(GENERAL DOCKET NO. 89-97)**

**Comment Date: August 30, 2005**

**Reply Date: September 14, 2005**

On April 20, 2005, the Region 5 (Southern California)<sup>1</sup> 800 MHz Regional Planning Committee submitted a proposed amendment to its Public Safety Plan that would allocate the following channels to Cocachella Water District and the City of San Diego:<sup>2</sup> 638, 647, 676, 685, 714, 723, 752, 790 and 816.<sup>3</sup>

The proposed amendment was reviewed by, and letters of concurrence obtained from, Southern California's adjacent regions, Region 3 (Arizona), Region 6 (Northern California), and Region 27 (Nevada).

In accordance with the National Public Safety Plan, each region is responsible for planning its use of public safety radio frequency spectrum in the 821-824/866-869 MHz bands.<sup>4</sup> The Region 5 Plan, which was originally adopted by the Commission in November 1989, has been modified several times

within the last sixteen years.<sup>5</sup>

Prior to taking action on the Region 5 Plan Amendment, by this Public Notice, we solicit comments on the Plan Amendment. Pursuant to Sections 1.415 and 1.419 of the Commission's Rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on the proposed Region 5 Plan Amendment on or before August 30, 2005 and reply comments on or before September 14, 2005. All comments should reference General Docket 89-97, and should be filed with the Office of the Secretary, Federal Communications Commission, 445 12th Street, S.W., TW-A325, Washington, D.C. 20554.
