## ENFORCEMENT BUREAU SEEKS COMMENT ON BELLSOUTH TELECOMMUNICATIONS, INC. SECTION 272 BIENNIAL AUDIT REPORT IN EB DOCKET NO. 03-197

Comments due: February 13, 2006

Pursuant to section 271 of the Communications Act of 1934, as amended (“Communications Act”),<sup>1</sup> the Commission has authorized BellSouth Telecommunications, Inc. (“BellSouth”) to enter the in-region interLATA market in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.<sup>2</sup> Section 272 of the Communications Act requires Bell Operating Companies to offer in-region, interLATA service through separate affiliates that comply with certain structural, nondiscrimination, and accounting safeguards. Section 272(d) requires a biennial audit.<sup>3</sup> We have received the results of the biennial audit of BellSouth’s operations in all of its in-region states for the period May 24, 2003 through May 23, 2005. The audit report, “BellSouth Telecommunications, Inc. Section 272 Biennial Agreed-Upon Procedures Engagement Pursuant to Section 272(d)(2) of The Telecommunications Act of 1996” was submitted by PricewaterhouseCoopers LLP on October 31, 2005.

Section 272(d)(2) of the Communications Act requires that the results of the audit be made publicly available.<sup>4</sup> We now release the BellSouth audit report. In accordance with section 53.213(d) of the Commission’s rules, interested parties may file comments on the report with the Commission within 60 days.<sup>5</sup> Accordingly, comments are due no later than February 13, 2006.

## EX PARTE PRESENTATIONS

Pursuant to section 1.1206 of the Commission's rules, this proceeding will be conducted as a permit-but-disclose proceeding in which ex parte communications are permissible but subject to disclosure.<sup>6</sup>

## FILING PROCEDURES

Interested parties may file comments on the biennial audit report using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>7</sup> Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and should include the following words in the body of the message, "get form <your e-mail address.>" A sample form and directions will be sent in reply.

Parties who choose to file by paper must file an original and four copies of each filing. All filings must be sent to the Commission's Secretary, Marlene H. Dortch, Office of the Secretary, Federal Communications Commission, 445 12th Street, S.W., CY-B402, Washington, D.C. 20554.

Parties who choose to file by paper should also submit their comments on diskette. Such a submission should be on a 3.5-inch diskette formatted in an IBM compatible format using Word or compatible software. The diskette should be accompanied by a cover letter and should be submitted in "read only" mode. The diskette should be clearly labeled with the commenter's name, proceeding (including the docket number, in this case EB Docket No. 03-197), type of pleading (comments), date of submission, and the name of the electronic file on the diskette. The label should also include the following phrase "Disk Copy - Not an Original." Each diskette should contain only one party's pleadings, preferably in a single electronic file.
