* On December 21, 2005, Hispanic Target Media, Inc. ("HTM"), an Auction No. 62 applicant, notified the Commission that HTM is no longer eligible for the new entrant bidding credit following the December 15, 2005, grant of its application for a construction permit for Carrizo Springs, Texas (File No. BNPH-20050103ABX). Accordingly, under the designated entity provisions of 47 C.F.R. Sections 73.5007 and 73.5008, the grant of the construction permit renders HTM ineligible for the 25% new entrant bidding credit, as claimed on its originally submitted FCC Form 175 application. Although the Qualified Bidder Public Notice released December 21, 2005, indicated a 25% bidding credit amount for HTM, the public notice as corrected by the erratum released December 23, 2005, indicates a 0% bidding credit.

** Two applicant names differ from those which appeared in the *Auction No. 62 Status Public Notice*. See "Auction of FM Broadcast Construction Permits; Status of FCC Form 175 Applications to Participate in Auction No. 62," *Public Notice*, DA 05-2892 (rel. November 9, 2005) ("*Auction No. 62 Status Public Notice*"). Applicant Smith Broadcasting, Inc. corrected its short-form application to reflect that it had applied as a corporation. It had initially appeared on the *Auction No. 62 Status Public Notice* as "Kent Smith." The applicant "Watermark Broadcasting LLC" notified the Commission of a *pro forma* assignment of its interests to "Watermark Communications LLC."
