**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE JOINT PETITION FOR
WAIVER OF BLUE VALLEY TELECOMMUNICATIONS, INC. AND UNITED TELEPHONE
COMPANY OF KANSAS TO WAIVE THE STUDY AREA BOUNDARY FREEZE, AS
CODIFIED IN PART 36 OF THE COMMISSION'S RULES AND
SECTION 69.3(e)(11) OF THE COMMISSION'S RULES**

On January 10, 2005, Blue Valley Telecommunications, Inc. (Blue Valley) and United Telephone Company of Kansas (United) filed a joint petition for waiver of the study area boundary freeze, as codified in the Appendix-Glossary of Part 36 of the Commission's rules.¹ The requested waiver would permit United to remove the Onaga and Westmoreland exchanges (approximately 1,586 access lines) from its existing Kansas study area. The waiver would allow Blue Valley to add the Onaga and Westmoreland exchanges to its existing Kansas study area. Blue Valley also seeks a waiver of section 69.3(e)(11) of the Commission's rules in order to continue to allow it to use the National Exchange Carrier Association as its tariff pool administrator.²

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before March 2, 2005 and reply comments on or before March 9, 2005. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg. 24121 (1998).

Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form." A sample form and directions will be sent in reply. Parties who choose to file by

paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail).
