The meetings of the Region 11 Public Safety Regional Planning Committees and State Interoperability Executive Committee are open to the public. All eligible public safety providers whose sole purpose or principal purpose is to protect the safety of life, health, or property in Hawaii may utilize these frequencies. It is essential that not only public safety, but all government, Native American Tribal, and non-governmental organizations eligible under Section 90.523 of the Federal Communications Commission's Rules be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not conversant with telecommunications technology should ensure that their respective agencies are represented suitably conversant staff.

All interested parties wishing to participate in the planning for use of public safety spectrum in the 700 MHz and 800 MHz bands within Region 11 are encouraged to attend. Participants can also join the meeting at State of Hawaii video conference centers located in Hilo, Wailuku, Honolulu, and Lihue.
