On January 19, 2006, Ameritech Illinois, Ameritech Indiana, Ameritech Michigan, Ameritech Ohio, and Ameritech Wisconsin (Ameritech), and Southwestern Bell Telephone Company (SWBT) filed petitions for pricing flexibility for certain special access and dedicated transport services in several designated geographic areas pursuant to sections 1.774 and 69.701 *et seq.* of the Commission's rules, 47 C.F.R. §§ 1.774 and 69.701 *et seq.* The petitions are available for review through the Commission's Electronic Tariff Filing System (ETFS). Comments or oppositions may be filed no later than February 3, 2006. Interested parties are strongly encouraged to file comments electronically through ETFS, although they are not required to do so. *See* 47 C.F.R. § 1.774(e)(2)(i). The ETFS provides instructions for filing both public and confidential versions of comments, and, if interested parties require additional assistance, they may call the ETFS Information Line at (202) 418-7700. Parties electing to file comments through a method other than ETFS must file such comments in accordance with section 1.774(e)(2)(ii) of the Commission's rules, 47 C.F.R. § 1.774(e)(2)(ii). In addition, Ameritech and SWBT may file replies no later than February 13, 2006, 10 days after the deadline for comments or oppositions. 47 C.F.R. § 1.774(d). Any such replies must be filed through ETFS. 47 C.F.R. 1.774(e)(3). For additional information about the filing and service of comments and replies, see sections 1.774(c)-(e) of the Commission's rules, 47 C.F.R. §§ 1.774(c)-(e). Paper filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor, Natek, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002.
