WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE PETITION OF GORHAM TELEPHONE COMPANY, INC., AND RURAL TELEPHONE SERVICE COMPANY, INC., TO WAIVE THE STUDY AREA BOUNDARY FREEZE, AS CODIFIED, IN PART 36, AND GORHAM TELEPHONE COMPANY'S REQUEST FOR WAIVER OF SECTION 69.3(e)(11) OF THE COMMISSION'S RULES

On June 15, 2006, Gorham Telephone Company, Inc., (Gorham) and Rural Telephone Service Company, Inc., (RuralTel) filed a joint petition for waiver of the study area boundary freeze as codified in the Appendix-Glossary of Part 36 of the Commission's rules.¹ Gorham also seeks a related waiver of section 69.3(e)(11) of the Commission's rules.²

The two exchanges subject to this transaction, Luray and Paradise (approximately 272 access lines in total), are currently part of the United Telephone Company of Kansas' (United) study area. RuralTel and United have a separate pending proceeding before the Commission requesting a study area waiver to allow RuralTel to add the Luray and Paradise exchanges and ten other exchanges to its Kansas

study area and to allow United to remove all 12 exchanges from its two Kansas study areas.³ The instant study area waiver would permit RuralTel to remove the Luray and Paradise exchanges from its Kansas study area and would permit Gorham to add the two exchanges to its Kansas study area after, and if, the RuralTel and United study area waiver is granted. Gorham also requests a waiver of section 69.3(e)(11) of the Commission's rules in order to continue to use the National Exchange Carrier Association as its tariff pool administrator upon completion of the transfer of the exchanges at issue.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415 and 1.419, interested parties are invited to comment on the Gorham-RuralTel Petition **on or before August 8, 2006** and **reply comments on or before August 15, 2006**. All pleadings are to reference CC Docket No. 96-45. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
