REGION 10 (GEORGIA) PUBLIC SAFETY PLANNING COMMITTEES
ANNOUNCE
700 MHz REGIONAL PUBLIC SAFETY PLANNING MEETING
AND
821 MHz REGIONAL REVIEW COMMITTEE MEETING
(PR Docket No. 92-189)

The Region 10 (Georgia) Public Safety Regional Planning Committees will hold two consecutive planning meetings on Tuesday, November 14, 2006.

The Region 10 700 MHz Regional Planning Committee meeting will be held from 10:00 a.m. to 12:00 p.m., at the Georgia Public Safety Training Center (GPSTC) auditorium, Exit 188, I-75, Forsyth, Georgia.

- The purpose of this meeting is to conduct a short election/re-election of officers and sub-committee members, and to review the draft Region 10 700 MHz Regional Plan to ensure that it meets the needs of the 700 MHz spectrum users including public safety, public health, emergency management and utility services.

Immediately following the 700 MHz meeting, the Region 10 821 MHz Regional Review Committee will convene its meeting beginning at 1:30 p.m. until 3:30 p.m.

- The purpose of this meeting is to review the progress of the 800 MHz band transition in Georgia, and to discuss the latest revision of the plan in effect. Based on recent applications received and processed, it is apparent that known requirements have already exceeded the availability of 821 MHz channels even since the last amendment. Reallocation of the channel assignments will be discussed and the resources available to reengineer the plan

Region 10 includes all of the counties and municipalities in the state of Georgia. Both of the Region 10 Public Safety Planning Committee meetings are open to the public. All eligible public safety providers whose sole purpose or principal purpose is to protect the safety of life, health, or property in Region 10 would utilize these frequencies. It is essential that not only

public safety, but all government, and non-governmental organizations eligible under Section 90.523 of the Commission's Rules, be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate and represent your agency's needs.

All interested parties wishing to participate in the planning for the use of the public safety spectrum in the 700 MHz and the 821 MHz bands are encouraged to attend. For further information about the meetings, please contact:
