**PLEADING CYCLE ESTABLISHED FOR COMMENTS  
ON VERIZON'S PETITIONS FOR FORBEARANCE  
IN THE BOSTON, NEW YORK, PHILADELPHIA, PITTSBURGH,  
PROVIDENCE, AND VIRGINIA BEACH METROPOLITAN STATISTICAL AREAS**

**WC Docket No. 06-172**

**Comments Due: October 30, 2006**  
**Reply Comments Due: November 29, 2006**

On September 6, 2006, the Verizon Telephone Companies (Verizon) filed six separate petitions pursuant to section 10 of the Communications Act of 1934, as amended,<sup>1</sup> requesting that the Commission forbear from applying to Verizon certain obligations in the Boston, New York, Philadelphia, Pittsburgh, Providence, and Virginia Beach Metropolitan Statistical Areas (MSAs).<sup>2</sup> Specifically, according to its Petitions, Verizon seeks forbearance from loop and transport unbundling obligations pursuant to 47 U.S.C. § 251(c) (47 C.F.R. § 51.319(a), (b), (e)); Part 61 dominant carrier tariffing requirements (*id.* §§ 61.32, 61.33, 61.58, 61.59); Part 61 price cap regulation (*id.* §§ 61.41-61.49); Computer III requirements including CEI and ONA requirements; and dominant carrier requirements arising under section 214 of the Act and Part 63 of the Commission's rules concerning the processes for acquiring lines, discontinuing services, assignment or transfers of control, and acquiring affiliations (*id.* §§ 63.03, 63.04, 63.60-63.66).<sup>3</sup> Verizon claims that competition in these six markets is even more advanced than

competition in the Omaha MSA, where the Commission granted in part a forbearance petition Qwest Corporation filed seeking similar relief.<sup>4</sup>

This Public Notice establishes certain procedural requirements relating to consideration of Verizon's Petitions. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to Section 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on the Verizon petitions for forbearance on or before October 30, 2006 and reply comments on or before November 29, 2006.
