COMMENTS INVITED ON APPLICATION OF CABLEVISION LIGHTPATH – CT, INC. TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

WC Docket No. 06-190
Comp. Pol. File No. 766

Section 214 Application

Applicant: Cablevision Lightpath – CT, Inc.

On **September 27, 2006, Cablevision Lightpath – CT, Inc.** (Cablevision or Applicant), located at **1111 Stewart Avenue, Bethpage, New York 11714**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain telecommunications services to customers located in the state of Connecticut.¹

Cablevision indicates that it provides local, toll, domestic long distance, and international service to residential customers in Connecticut. Cablevision states that it intends to discontinue the provision of these services to residential customers on or about November 13, 2006.² Cablevision, however, clarifies that it plans to continue to provide service to commercial customers in Connecticut. Cablevision indicates that it provided notice of its proposed discontinuance to all affected residential customers by letters sent on July 31, 2006. Cablevision further represents that follow-up correspondence was sent to customers that had not yet selected a new provider, and that another follow-up letter will be sent at least fifteen days prior to the proposed discontinuance date. Finally, Cablevision states that it is regulated as a non-dominant carrier with respect to the services it proposes to discontinue.

In accordance with section 63.71(c) of the Commission's rules, Cablevision's application will be deemed to be automatically granted on the thirty-first (31st) day after the release date of this public notice, unless the Commission notifies Cablevision that the grant will not be automatically effective.

² Discontinuance of international service is governed by 47 C.F.R. § 63.19.

Accordingly, pursuant to section 63.71(c), absent further Commission action, Cablevision may terminate service to its affected customers on **November 18, 2006**. The Commission will normally authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **November 1, 2006**. Such comments should refer to **WC Docket No. 06-190** and **Comp. Pol. File No. 766**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the body of the message, “get form.” A sample form and directions will be sent in response.
