CONSUMER AND GOVERNMENTAL AFFAIRS BUREAU ACTION

EXTENSION OF COMMENT PERIOD ON PETITIONS FOR EXEMPTION FROM COMMISSION'S CLOSED CAPTIONING RULES; *EX PARTE* TREATMENT OF FILINGS IN DOCKET

CG Docket No. 06-181

On November 7, 2006, the Consumer and Governmental Affairs Bureau (Bureau) placed on public notice 494 petitions requesting exemption from the closed captioning requirements for their programs, pursuant to section 79.1 of the Commission's Rules, 47 C.F.R. § 79.1.¹ Each petitioner claims that compliance with the closed captioning requirements would impose an undue burden, as defined in section 79.1(f) of the Commission's rules, 47 C.F.R. § 79.1(f). The *November 7 Public Notice* solicited comment on these petitions and set a 20-day comment period.

The Commission received two motions for extension of time to file comments.² In response to these requests, we extend the comment period on the petitions for exemption listed in the *November 7 Public Notice* by 120 days. The parties requesting an extension of time assert that they face a great burden in reviewing, evaluating and responding individually to each of the 494 petitions for exemption within the 20-day comment period.³ They also argue, *inter alia*, that an extension of time is warranted because the interests of petitioners who have requested exemptions will not be affected adversely by an extended comment period, as parties are exempt from the closed captioning requirements pending Commission review of their undue burden petitions.⁴ We believe that the requests for extension of time are reasonable in light of the number of petitions

that were placed on public notice and, therefore, we extend the comment period by 120 days. Comments on and oppositions to petitions listed in the *November 7 Public Notice* now are due no later than March 27, 2007. We also establish a 40-day period for the filing of replies to these comments and oppositions.

Petitioners also seek a limited waiver of the Commission's service rules, requesting that "the service requirement of Section 1.47(g) be waived for all parties other than Petitioner."⁵ Section 1.47(g) provides that all comments, oppositions, and replies must be served on the relevant petitioner(s), commenting parties, or opposing parties, and shall include a certification that such service occurred. Petitioners state that they "do not seek this waiver for their benefit, as they intend to serve all parties in this proceeding in accordance with the Commission's rules. However, requiring commenters, including individual members of the public, to serve up to 500 parties is overly burdensome and outweighs the benefits of service." We agree that the requested waiver is warranted under the circumstances before us and accordingly grant Petitioners' request for waiver of the service requirement of Section 1.47(g) for comments filed electronically by commenters other than Petitioners in CG Docket No. 06-181.⁶ We note that all petitions and related pleadings are available electronically, under docket number CG Docket No. 06-181, on the Commission's ECFS web site.

Ex Parte Presentations. Unless otherwise provided, requests for waiver of the Commission's rules are subject to treatment by the Commission as restricted proceedings for *ex parte* purposes under section 1.1208 of the Commission's Rules, 47 C.F.R. § 1.1208. Because of the policy implications and potential impact of the collective proceedings in CG Docket No. 06-181 on persons not necessarily party to each individual petition for exemption, we believe it would be in the public interest to treat CG Docket No. 06-181 as a permit-but-disclose proceeding under the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200(a) and 1.1206. All *ex parte* filings and contacts associated with the petitions for exemption listed below in CG Docket No. 06-181 shall comport with the Commission's rules for permit-but-disclose proceedings. See *id.* Further, any petition filed in this docket in the future also will be subject to permit-but-disclose treatment for *ex parte* purposes. Therefore, *ex parte* presentations will be permitted but must be disclosed in accordance with the requirements of section 1.1206(b) of the Commission's Rules, 47 C.F.R. § 1.1206(b). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See *id.* Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.

Filing Instructions –

Each filing must reference CG Docket No. 06-181, as well as the particular case identifier(s) to which the filing is directed.

Comments, oppositions, replies, and *ex parte* letters may be filed electronically through the Commission's Electronic Comment Filing System (ECFS) at http://gullfoss2.fcc.gov/prod/ecfs/upload_v2.cgi. Key 06-181 in box 1 labeled "Proceeding," and click on "comment," "opposition," "reply," or "letter," as appropriate, in box 12 labeled "Document Type." Be sure to follow all other directions on the page.

If filing paper copies, an original and two (2) copies of all comments, oppositions, and replies must be filed with the Commission. Parties making *ex parte* presentations must comply with section 1.1206 of the Commission's rules. Filings can be sent by hand or messenger delivery, commercial overnight courier, or by first class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S.
