Interested parties are invited to comment on the petition filed by Cingular Wireless, LLC seeking designation as an eligible telecommunications carrier (ETC) in the Commonwealth of Virginia pursuant to section 214(e)(6) of the Communications Act of 1934, as amended.<sup>1</sup>

Pursuant to Sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file **comments on or before December 4, 2006**, and **reply comments on or before December 11, 2006**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

More than a one or two sentence description of the views and arguments presented generally is required.<sup>3</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>4</sup>
