**PLEADING CYCLE ESTABLISHED FOR COMMENTS ON AT&T's REQUEST FOR LIMITED MODIFICATION OF THE LATA BOUNDARY TO PROVIDE EXPANDED LOCAL CALLING SERVICE BETWEEN THE TALCO AND PARIS EXCHANGES IN THE STATE OF TEXAS**

**WC DOCKET NO. 06-69**

**Comments Due: April 24, 2006**  
**Reply Comments Due: May 9, 2006**

By this Public Notice, we seek comment on a petition filed on March 16, 2006 by Southwestern Bell Telephone, d/b/a AT&T Texas (AT&T) requesting a limited modification of the local access and transport area (LATA) boundary to provide expanded local calling service between AT&T's Paris exchange and the Talco exchange, served by Peoples Telephone Cooperative, Inc. Both exchanges are in Texas.

This Public Notice establishes certain procedural requirements relating to consideration of AT&T's petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented is generally required. See 47 C.F.R. § 1.1206(b). Other requirements pertaining to oral and written presentations are set forth in section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R §§ 1.415, 1.419, interested parties may file comments on or before **April 24, 2006** and reply comments on or before **May 9, 2006**. All filings should refer to WC Docket No. **06-69**. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 FR 24121 (1998).

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or

rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number.
