## AT&T FILES COST ALLOCATION MANUAL REVISION

### I. COST ALLOCATION MANUAL REVISION

1. In this public notice, we seek comment on the Cost Allocation Manual (CAM) revision filed by AT&T Inc. on behalf of the Southern New England Telephone Company (AT&T) on March 24, 2006. AT&T's revision reflects changes to the nonregulated activities, affiliate transactions, and cost apportionment sections of the CAM.

### II. PROCEDURAL MATTERS

2. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>1</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented is generally required.<sup>2</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>3</sup>

3. Interested parties may file comments on or before May 4, 2006, and reply comments on or before May 19, 2006. All such filings shall refer to the internal file number:
