**REGION 45 (WISCONSIN) PLANNING COMMITTEES TO HOLD**

**700 MHz ANNUAL REGIONAL PUBLIC SAFETY PLANNING MEETING**  
**AND**  
**NPSPAC 800 MHz ANNUAL REGIONAL PUBLIC SAFETY PLANNING MEETING**  
**(PR Docket No. 92-273)**

The Region 45 (Wisconsin)<sup>1</sup> Regional Planning Committees will hold two consecutive planning meetings on Thursday, May 11, 2006, from 10:00 a.m. to 12:00 p.m. at the Wisconsin State Patrol District 3 Post located at 851 Rolling Meadows Drive in Fond du Lac.<sup>2</sup>

- The purpose of the Region 45 (Wisconsin) 700 MHz annual meeting is to review the Region 45 700 MHz Plan and feedback from adjacent regions.
- The Region 45 (Wisconsin) 800 MHz annual meeting will include the review of the current 800 MHz activity in Region 45, along with a progress update on the re-banding process.

Both of the Region 45 Public Safety Regional Planning Committee meetings are open to the public. All eligible public safety providers whose sole purpose or principal purpose is to protect the safety of life, health, or property in Region 45 would utilize these frequencies. It is essential that not only public safety, but all government, Native American Tribal, and non-governmental organizations eligible under Section 90.523 of the Commission's Rules be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not conversant with telecommunications technology should ensure that their respective agencies are represented by suitably conversant staff.
