DOMESTIC SECTION 214 APPLICATION FILED FOR THE ACQUISITION OF ASSETS OF NATIONSLINE NEW JERSEY, INC., NATIONSLINE DELAWARE, INC., AND NATIONSLINE NORTH, INC. BY INFINITE COMMUNICATION, LLC

STREAMLINED PLEADING CYCLE ESTABLISHED

The following application was filed pursuant to section 63.03 of the Commission's rules by Infinite Communication, LLC ("Infinite"), NationsLine New Jersey, Inc. ("NationsLine NJ"), NationsLine Delaware, Inc. ("NationsLine DE") and NationsLine North, Inc. ("NationsLine North," together with NationsLine NJ and NationsLine DE, "NationsLine") (NationsLine, together with Infinite, "Applicants"), requesting authority to transfer certain assets, including equipment, various contracts, customers, and governmental authorizations, from NationsLine to Infinite.¹ NationsLine provides interexchange and competitive local exchange telecommunications services in New Jersey, Delaware, and Pennsylvania. Infinite does not currently provide telecommunications service and is owned by four U.S. citizens, each holding a 25% equity interest: Michael Miller, Kevin McGeary, Raymond Fireman, and Barry Fireman. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.²

GENERAL INFORMATION

The transfer of assets identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of assets application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file **comments on or before March 22, 2007** and **reply comments on or before March 29, 2007**.³ Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets and related control on the 31st day after the date of this notice.⁴ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
