The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer certain assets of Marathon Communications Corp. d/b/a Marathon USA ("Marathon") to BCN Telecom, Inc. ("BCN," together with Marathon, "Applicants"), both U.S. corporations. Marathon provides intrastate, interexchange services in 43 states. BCN provides resold intrastate and interstate services in 25 states and the District of Columbia. Pursuant to an Asset Purchase Agreement, BCN will acquire all assets relating to Marathon's existing residential and business customers. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.<sup>2</sup>
