**THE WIRELINE COMPETITION BUREAU SEEKS COMMENT ON A PETITION BY
NORTHWEST MISSOURI CELLULAR LIMITED PARTNERSHIP TO REDEFINE THE STUDY
AREAS OF THREE RURAL TELEPHONE COMPANIES IN MISSOURI**

The Wireline Competition Bureau (Bureau) seeks comment on a petition filed by Northwest Missouri Cellular Limited Partnership pursuant to section 54.207 of the Commission's rules, 47 C.F.R. § 54.207, requesting the Commission's agreement with the decision of the Missouri Public Service Commission (MPSC) to redefine the study areas of three rural telephone companies at the wire center level.¹

Section 54.207 of the Commission's rules, which implements section 214(e)(5) of the Communications Act of 1934 (Act), as amended, provides that a rural telephone company's service area will be its study area "unless and until the Commission and the states, after taking into account the recommendations of a Federal-State Joint Board instituted under section 410(c) of the Act, establish a different definition of service area for such company."²

The Bureau issues this Public Notice as required by section 54.207(c)(2) of the Commission's rules.³ If the Commission initiates a proceeding to consider the Petition, it must do so within 90 days of the release date of this Public Notice, pursuant to our rules.⁴ If the Commission does not act on the

Petition by **July 2, 2007**, the definition proposed by the MPSC will be deemed approved by the Commission and shall take effect in accordance with state procedures.⁵

Pursuant to Sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **April 16, 2007**, and reply comments on or before **April 23, 2007**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies.⁶

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the body of the message, "get form." A sample form and directions will be sent in response.
- **Paper Filers:** Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

The Commission's contractor will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002.
