SEEKS FCC CONSENT TO THE TRANSFER OF CONTROL OF LICENSES HELD BY
BELLSOUTH WIRELESS CABLE, INC. AND SOUTH FLORIDA TELEVISION, INC. FROM
AT&T INC. TO CLEARWIRE SPECTRUM HOLDINGS II LLC**

I. INTRODUCTION

Clearwire Spectrum Holdings II LLC (the "Applicant") has filed applications pursuant to Section 310(d) of the Communications Act of 1934, as amended.¹ In these applications, the Applicant seeks Commission approval of the transfer of control of Broadband Radio Service ("BRS") licenses held by BellSouth Wireless Cable, Inc. and South Florida Television, Inc. from AT&T Inc. to Clearwire Spectrum Holdings II LLC ("Clearwire").²

II. SECTION 310(d) APPLICATION

The following applications for consent to transfer control of BRS licenses to Clearwire have been assigned the file numbers listed below.

III. EX PARTE STATUS OF THIS PROCEEDING

Pursuant to section 1.1200(a) of the Commission's rules,³ the Commission may adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires. We announce that this proceeding will be governed by permit-but-disclose *ex parte* procedures that are applicable to non-restricted proceedings under section 1.1206 of the Commission's rules.⁴

Parties making oral *ex parte* presentations are directed to the Commission's statement reemphasizing the public's responsibility in permit-but-disclose proceedings and are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list the subjects discussed.⁵ More than a one- or two-sentence description of the views and arguments presented is generally required.⁶ Other rules pertaining to oral and written presentations are set forth in section 1.1206(b) as well.⁷ We urge parties to use the Electronic Comment Filing System ("ECFS") to file *ex parte* submissions.⁸

IV. GENERAL INFORMATION

The transfer of control application referenced herein has been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return the application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies. Final action on this application will not be taken earlier than thirty-one days following the date of this Public Notice.⁹

Interested parties must file petitions to deny no later than **May 7, 2007**. Persons and entities that file petitions to deny become parties to the proceeding. They may participate fully in the proceeding, including seeking access to any confidential information that may be filed under a protective order, seeking reconsideration of decisions, and filing appeals of a final decision to the courts. Oppositions to such pleadings must be filed no later than **May 17, 2007**. Replies to such pleadings must be filed no later than **May 24, 2007**. All filings concerning matters referenced in this Public Notice should refer to DA 07-1647 and WT Docket No. 07-70, as well as the specific file number of the individual application or other matters to which the filings pertain.

Under the Commission's current procedures for the submission of filings and other documents,¹⁰ submissions in this matter may be filed electronically (*i.e.*, through ECFS) or by hand delivery to the Commission's Massachusetts Avenue location.

- **If filed by ECFS,**¹¹ comments shall be sent as an electronic file via the Internet to <http://www.fcc.gov/e-file/ecfs.html>. In completing the transmittal screen, commenters should include their full name, Postal Service mailing address, and the applicable docket number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form <your e-mail address>." A sample form and directions will be sent in reply.
