**APPLICATION FOR DOMESTIC SECTION 214 TRANSFER OF CONTROL OF  
WESTCOM CORPORATION AND KGM CIRCUIT SOLUTIONS, LLC FROM  
WESTCOM HOLDING CORP. TO IPC SYSTEMS, INC.**

**STREAMLINED PLEADING CYCLE ESTABLISHED**

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of the domestic section 214 authorizations held by Westcom Corporation ("Westcom") and KGM Circuit Solutions, LLC ("KGM") from WestCom Holding Corp. (WHC) to IPC Systems, Inc. ("IPC," collectively, "Applicants").<sup>1</sup> Westcom and KGM, wholly-owned subsidiaries of WHC, provide dedicated private line services in multiple states with their primary operations in New York, Illinois, New Jersey, California, Connecticut, Texas, Maryland, Massachusetts, Pennsylvania, North Carolina, Minnesota, Florida, and Virginia. IPC, through its wholly owned subsidiary, IPC Network Services, Inc., provides primarily dedicated private line services in all of the above states, except Florida, as well as in multiple other states. All Applicants are U.S. entities. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules<sup>2</sup> and that a grant of the application will serve the public interest, convenience, and necessity.

## GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file **comments on or before April 27, 2007** and **reply comments on or before May 4, 2007**.<sup>3</sup> Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets and related control on the 31<sup>st</sup> day after the date of this notice.<sup>4</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
