## DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF TELEPHONE SERVICE COMPANY TO HANSON COMMUNICATIONS, INC

### STREAMLINED PLEADING CYCLE ESTABLISHED

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of Telephone Service Company ("TSC") and its subsidiary, TSC Communications, Inc. ("TSCCI,"), to Hanson Communications, Inc. ("Hanson," collectively, "Applicants"), all U.S. corporations.<sup>1</sup> TSC is an incumbent local exchange carrier ("LEC") serving three rural exchanges in Ohio: Wapakoneta, Cridersville, and Uniopolis in Auglaize County. TSC also provides resold long distance services to these exchanges. TSCCI provides competitive local exchange services in portions of Auglaize and Allen Counties in Ohio. Hanson, which operates as a telecommunications holding company, owns five incumbent LECs serving rural exchanges in Minnesota and South Dakota. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(iii) of the Commission's rules<sup>2</sup> and that a grant of the application will serve the public interest, convenience, and necessity.

### GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47

CFR §§ 1.415, 1.419, interested parties may file **comments on or before May 7, 2007** and **reply comments on or before May 14, 2007**.<sup>3</sup> Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets a related control on the 31<sup>st</sup> day after the date of this notice.<sup>4</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
