COMMENTS INVITED ON APPLICATION OF RCN TELECOM SERVICES OF ILLINOIS, LLC TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

WC Docket No. 07-89
Comp. Pol. File No. 789

Section 214 Application

Applicant: RCN Telecom Services of Illinois, LLC

On **March 28, 2007**, **RCN Telecom Services of Illinois, LLC** (RCN or Applicant), located at **2640 W. Bradley Place, Chicago, IL 60618**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain domestic telecommunications services in Chicago, Illinois. On April 25, 2007, RCN provided additional information clarifying its application. Accordingly, RCN's application is deemed complete as of April 25, 2007.

RCN indicates that it currently provides local exchange, domestic and international long distance services to customers receiving service via the UNE loop platform in Chicago. RCN states, however, that it has revised its business plan and now intends to discontinue its provision of these services in Chicago.¹ According to RCN, the anticipated date for the proposed discontinuance is May 29, 2007, or as soon thereafter as the necessary state and federal approvals can be obtained. RCN indicates that it notified affected customers of the proposed discontinuance by letters mailed on March 26, 2007. RCN points out that it has offered to migrate these customers to its digital services. Additionally, RCN notes that alternative providers of equivalent services are readily available. Finally, RCN asserts that it is non-dominant with respect to the services it proposes to discontinue.

In accordance with section 63.71(c) of the Commission's rules, RCN's application will be deemed to be granted automatically on the thirty-first (31st) day after the release date of this public notice, unless the Commission notifies RCN that the grant will not be automatically effective. In RCN's application and notice to its customers, RCN indicates that it anticipates discontinuing service on May 29, 2007. Accordingly, pursuant to section 63.71(c) and the terms of RCN's notice and application,

absent further Commission action, RCN may terminate service on **May 29, 2007**. The Commission will normally authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **May 14, 2007**. Such comments should refer to **WC Docket No. 07-89 and Comp. Pol. File No. 789**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the body of the message, “get form.” A sample form and directions will be sent in response.
