DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF INFRASOURCE SERVICES, INC., SUNESYS, LLC AND SUNESYS OF VIRGINIA, INC. TO QUANTA SERVICES, INC.

#### STREAMLINED PLEADING CYCLE ESTABLISHED

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of InfraSource Services, Inc. ("IFS"), Sunesys, LLC ("Sunesys"), and Sunesys of Virginia, Inc. ("Sunesys VA") to Quanta MS Acquisition, Inc., a wholly owned subsidiary of Quanta Services, Inc. ("Quanta"). All of these entities are U.S.-based. Sunesys and Sunesys VA are wholly owned subsidiaries of InfraSource Incorporated ("InfraSource"), whose ultimate corporate parent is IFS. Sunesys currently provides competitive telecommunications services to business customers in California, Georgia, Maryland, New Jersey, and Pennsylvania, and is authorized to provide service in several other states. Sunesys VA is authorized to provide competitive telecommunications services in Virginia. Quanta, which provides contracting services for electric, gas, telecommunications, and cable television networks, does not currently offer telecommunications services. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules² and that a grant of the application will serve the public interest, convenience, and necessity.

#### **GENERAL INFORMATION**

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file **comments on or before May 30, 2007** and **reply comments on or before June 6, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets and related control on the 31<sup>st</sup> day after the date of this notice.<sup>3</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
