# DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF COMTEL TELCOM ASSETS LP AND COMTEL VIRGINIA LLC

#### STREAMLINED PLEADING CYCLE ESTABLISHED

Comments Due: May 31, 2007 Reply Comments Due: June 7, 2007

On May 11, 2007, Comtel Telcom Assets LP ("Comtel") and Comtel Virginia LLC ("Comtel-VA") (together, "Applicants"), filed the following application pursuant to section 63.03 of the Commission's rules¹ requesting approval to transfer control of Comtel and Comtel-VA. Comtel is a Texas limited partnership that provides interstate and intrastate long distance service throughout the United States.² Comtel-VA, a Virginia limited liability corporation and a wholly-owned subsidiary of Comtel, is authorized to provide local exchange and exchange access services in Virginia. Applicants request consent to transfer control of Comtel from Mr. Jeff Larson, a U.S. citizen and the ultimate manager of Comtel, to Stuart Porter, a U.S. citizen and current interest holder in Comtel. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.³

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file comments **on or before May 31, 2007** and reply comments **on or before June 7, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer control on the 31<sup>st</sup> day after the date of this notice. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies.
