## COMMENTS INVITED ON APPLICATION OF RCN TELECOM SERVICES OF ILLINOIS, LLC TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

**WC Docket No. 07-111**  
**Comp. Pol. File No. 796**

### Section 214 Application

**Applicant: RCN Telecom Services of Illinois, LLC**

On **May 17, 2007**, **RCN Telecom Services of Illinois, LLC** (RCN or Applicant), located at **2640 W. Bradley Place, Chicago, IL 60618**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain domestic telecommunications services in Illinois.

RCN indicates that it currently provides local exchange and domestic and international long distance service to customers receiving service via the UNE loop platform from the Edgewater central office in Chicago, Illinois. RCN states, however, that it has revised its business plan and now intends to discontinue its provision of these services via the UNE loop platform in Chicago, Illinois.<sup>1</sup> According to RCN, the anticipated date for the proposed discontinuance is June 28, 2007, or as soon thereafter as the necessary state and federal approvals can be obtained. RCN maintains that the basic local telephone services that are being discontinued are available from other carriers. RCN states that customers have also been given the option of migrating to RCN's digital service platform. RCN indicates that it provided notice of the proposed discontinuance to all affected customers in accordance with section 63.71 of the Commission's rules by letters mailed on April 27, 2007. Finally, RCN asserts that it is non-dominant with respect to the services it proposes to discontinue.

In accordance with section 63.71(c) of the Commission's rules, RCN's application will be deemed to be granted automatically on the thirty-first (31st) day after the release date of this public notice, unless the Commission notifies RCN that the grant will not be automatically effective. In RCN's application and notice to its customers, RCN indicates that it anticipates discontinuing service on June 28, 2007. Accordingly, pursuant to section 63.71(c) and the terms of RCN's notice and application,

absent further Commission action, RCN may terminate service in Chicago, Illinois on **June 28, 2007**. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **June 11, 2007**. Such comments should refer to **WC Docket No. 07-111 and Comp. Pol. File No. 796**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail.
