## PLEADING CYCLE ESTABLISHED FOR COMMENTS ON THE KENTUCKY PUBLIC SERVICE COMMISSION'S PETITION FOR ADDITIONAL DELEGATED AUTHORITY TO IMPLEMENT NUMBER CONSERVATION MEASURES

CC Docket Nos. 99-200 and 96-98

**Comments Due: February 12, 2007**  
**Reply Comments Due: February 27, 2007**

On October 10, 2006, the Kentucky Public Service Commission (Kentucky PSC) filed a petition for delegated authority to implement additional number conservation measures.<sup>1</sup> In an effort to extend the life of the 270 numbering plan area (NPA), the Kentucky PSC requests delegated authority to implement mandatory thousands-block number pooling in local number portability (LNP)-capable rate centers in rural areas of the state. The Kentucky PSC indicates that authority to ensure that numbers are assigned in one thousand blocks, rather than blocks of ten thousand, would utilize existing numbering resources that would otherwise remain stranded and prolong the life of the 270 NPA.

This Public Notice establishes certain procedural requirements relating to consideration of the Kentucky PSC's request. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented is generally required. See 47 C.F.R. § 1.1206(b). Other requirements pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R §§ 1.415, 1.419, interested parties may file comments on or before **February 12, 2007** and reply comments on or before **February 27, 2007**. All filings should refer to **CC Docket No. 99-200 and CC Docket No. 96-98**.

Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 FR 24121 (1998).
