**DOMESTIC SECTION 214 APPLICATION FILED FOR THE ACQUISITION OF  
CERTAIN ASSETS OF TRINSIC COMMUNICATIONS, INC. BY  
COMMUNICATIONS XCHANGE, LLC**

**STREAMLINED PLEADING CYCLE ESTABLISHED**

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer certain assets of Trinsic Communications, Inc. ("Trinsic Communications") to Communications Xchange, LLC ("CommX") (together with Trinsic, the "Applicants").<sup>1</sup> Trinsic Communications, a Delaware corporation, is a wholly-owned subsidiary of Trinsic, Inc., a Delaware corporation that provides interexchange services nationwide. Trinsic Communications is authorized to provide competitive local exchange and interexchange services nationwide with the exception of Alaska. CommX, a Florida limited liability company, is wholly-owned by CommX Holdings, Inc., a U.S.-based entity that does not have any telecommunications affiliates. Applicants state that, under the terms of the proposed transaction, CommX will acquire Trinsic's customers in Florida and New York that currently receive service via Trinsic's switches.<sup>2</sup>

<sup>2</sup> On February 7, 2007, Trinsic Communications filed a petition for relief under Chapter 11 of the United States Bankruptcy Code in the Bankruptcy Court for the Southern District of Alabama. Following a court-supervised auction, Trinsic Communications entered into an Asset Purchase Agreement (APA) to sell substantially all of its assets to Tide Acquisition Corporation ("Tide"). Tide subsequently assigned its purchasing rights to Matrix Telecom, Inc. ("Matrix"). On May 29, 2007, the Commission granted the domestic section 214 application filed for the Matrix acquisition of assets. Notice of Domestic Section 214 Authorization Granted, WC Docket No. 07-87, Public Notice, DA 07-2227 (rel. May 29, 2007). Applicants state that the Trinsic Communications assets to be transferred to CommX are not part of the APA.

The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules<sup>3</sup> and that a grant of the application will serve the public interest, convenience, and necessity.

## **GENERAL INFORMATION**

The transfer of assets identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file **comments on or before July 17, 2007** and **reply comments on or before July 24, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets on the 31<sup>st</sup> day after the date of this notice.<sup>4</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
