## COMMENTS SOUGHT ON EMBARQ PETITION FOR WAIVER TO ALLOW IT TO EXERCISE PRICING FLEXIBILITY FOR CERTAIN PACKET-SWITCHED SERVICES

On July 2, 2007, Embarq filed a petition requesting that the Commission waive certain rules in order to permit Embarq to exercise pricing flexibility for certain services that use packet-switched technology, which it calls Specialized Network Services. Specifically, Embarq seeks this relief for Frame Relay, Wide Area Data Network, and Asynchronous Transfer Mode Services and Custom Access Solutions in those areas where Embarq has already qualified for pricing flexibility for other special access services. Embarq asserts that it seeks the same pricing flexibility relief for its packet-switched services that was previously granted by the Commission to AT&T, Qwest, and Verizon.

Interested parties may file comments on or before **July 23, 2007**, and reply comments on or before **July 30, 2007**. Filings in this proceeding should be captioned "In the Matter of Embarq Petition for Waiver of Pricing Flexibility Rules for Specialized Network Services" and filed in WC Docket No. 07-142. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>4</sup>
