## DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF NEON OPTICA, INC. TO RCN CORPORATION

### STREAMLINED PLEADING CYCLE ESTABLISHED

**WC Docket No. 07-152**

**Comments Due: August 9, 2007**  
**Reply Comments Due: August 16, 2007**

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of the domestic section 214 authorization held by NEON Optica, Inc. ("NEON") to RCN Corporation ("RCN") (collectively, "Applicants").<sup>1</sup> NEON, a Delaware corporation, is a wholly owned subsidiary of NEON Communications, Inc., which in turn is a wholly owned subsidiary of NEON Communications Group, Inc., both U.S.-based corporations. NEON and its affiliates, NEON Connect, Inc., Northeast Optic Network of Connecticut, Inc., NorthEast Optic Network of New York, Inc., and NEON Virginia Connect, LLC are authorized to provide competitive telecommunications services in 11 northeast and mid-Atlantic states<sup>2</sup> and the District of Columbia. RCN, a publicly traded Delaware corporation, is authorized through its U.S.-based affiliates to provide competitive local and long distance services in the same Northeast and mid-Atlantic states as NEON, and the District of Columbia, except that NEON is authorized to provide service in New Hampshire, while RCN is not. RCN is also authorized to provide competitive service in Illinois. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.<sup>3</sup>

## **GENERAL INFORMATION**

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file comments **on or before August 9, 2007** and reply comments **on or before August 16, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer control on the 31<sup>st</sup> day after the date of this notice.<sup>4</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
