On July 17, 2007, Consolidated Communications Holdings, Inc. ("CCH") and North Pittsburgh Systems, Inc. ("NPSI", together with CCH, "Applicants"), filed an application pursuant to section 63.03 of the Commission's rules requesting approval to transfer control of NPSI and its subsidiaries to CCH. NPSI is a publicly-traded Pennsylvania holding corporation. NPSI's wholly-owned subsidiaries are: North Pittsburgh Telephone Company ("NPTC") and Penn Telecom, Inc. ("Penn Telecom"), both of which are incorporated in Pennsylvania. NPTC is an incumbent local exchange carrier ("LEC") offering traditional voice and broadband services in Allegheny, Armstrong, Butler, and Westmoreland counties in Western Pennsylvania. Penn Telecom is a competitive LEC offering voice and broadband services in the metropolitan Pittsburgh area. CCH is a Delaware corporation that, through its operating subsidiaries, all U.S. corporations, offers services as an incumbent LEC and competitive LEC to customers in Illinois and in Texas. The only 10% or greater interest holder in CCH is Richard A. Lumpkin, a U.S. citizen.

Another affiliate of CCH, Consolidated Communications Network Services, Inc., provides competitive LEC and long distance services in Illinois and Texas. Consolidated Communications Public Services, Inc. provides inmate payphone services and Consolidated Communications Telecom Services of Texas Company provides long distance services.

³ Mr. Lumpkin holds an indirect interest in CCH through the following ownership chain: CCH is wholly-owned by Consolidated Communications, a U.S. corporation. Consolidated Communications is partly owned (25%) by Central Illinois Telephone, LLC (CIT), a U.S. limited liability company, which is owned (81.9%) by SKL Investment Group (SKL), a Delaware limited liability company. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under sections 63.03(b)(2)(ii) and (iii) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.⁴
