**DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF
INTER-TEL NETSOLUTIONS, INC. FROM INTER-TEL (DELAWARE), INC.
TO MITEL NETWORKS CORPORATION**

STREAMLINED PLEADING CYCLE ESTABLISHED

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of the domestic section 214 authorization held by Inter-Tel NetSolutions, Inc. ("NetSolutions") from Inter-Tel (Delaware), Inc. ("Inter-Tel") to Mitel Networks Corporation ("Mitel") (collectively, "Applicants").¹ NetSolutions, a Texas corporation, is a wholly-owned subsidiary of Inter-Tel, a publicly-traded Delaware corporation that has not received authority under section 214 of the Act. NetSolutions provides domestic resold local, intrastate, and/or interstate telecommunications services nationwide. Applicants state that Mitel, a Canadian corporation, does not provide domestic telecommunications service. The following entities directly or indirectly own at least 10 percent of the equity of Mitel: Terry Matthews, a Canadian citizen (32.6 percent), Arsenal Holdco Sàrl, a Luxembourg-based investment entity (38 percent), Francisco Partners II (Cayman) L.P., a Cayman Islands entity that owns 100 percent of Arsenal Holdco Sàrl, Francisco Partners GP II (Cayman) L.P., a Cayman Islands entity that is the general partner of Francisco Partners II (Cayman) L.P., and Francisco Partners GP II Management (Cayman) Limited, a Cayman Islands entity that is the general partner of Francisco Partners GP II (Cayman) L.P. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.²

GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file comments **on or before August 14, 2007** and reply comments **on or before August 21, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer control on the 31st day after the date of this notice.³ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
