## LPTV AND TV TRANSLATOR PROPOSALS DISMISSED FOR FAILURE TO SUBMIT LONG-FORM APPLICATIONS (AUCTION NO. 81)

On July 10, 2007, the Media Bureau and Wireless Telecommunications Bureaus (the Bureaus) announced that certain engineering proposals for Low Power Television (LPTV), TV translator and Class A TV stations received during the August 2000 filing window (Auction No. 81) were no longer mutually exclusive with any other proposal submitted in the filing window.<sup>1</sup> The Bureaus instructed the applicants that submitted these specified proposals to file a correct and complete long-form application (FCC Form 346) electronically no later than August 9, 2007.<sup>2</sup> Certain applicants did not file their required long-form application by the deadline on August 9, 2007, and their proposals, as specified in Attachment A, are hereby dismissed.<sup>3</sup>
