**DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL
OF INDEPENDENT TELECOMMUNICATIONS SYSTEMS, INC. TO CAPITAL GROWTH
SYSTEMS, INC**

STREAMLINED PLEADING CYCLE ESTABLISHED

On August 15, the following application was filed pursuant to section 63.03 of the Commission's rules requesting approval to transfer control of Independent Telecommunications Systems, Inc. ("ITS") to Capital Growth Systems, Inc. ("CGSY") (collectively "Applicants").¹ Independent Telecommunications Systems, Inc., a Michigan corporation, provides domestic resold intrastate and interstate telecommunications services on a retail basis in the following states: Alabama, California, Florida, Illinois, Kentucky, Maryland, Michigan, Mississippi, Ohio, Pennsylvania, Tennessee, Texas, Washington, Virginia and Wisconsin. Capital Growth Systems, Inc., a publicly-traded Florida corporation, does not provide domestic telecommunications services in the United States. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(1)(ii) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.²

GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file comments **on or before September 6, 2007**, and reply comments **on or before September 13, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer control on the 31st day after the date of this notice.³ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
