**COMMENTS INVITED ON APPLICATION OF SBC LONG DISTANCE, LLC  
D/B/A AT&T LONG DISTANCE TO DISCONTINUE DOMESTIC  
TELECOMMUNICATIONS SERVICES**

**Section 214 Application**

**Applicant: SBC Long Distance, LLC d/b/a AT&T Long Distance**

On **June 27, 2007**, **SBC Long Distance, LLC d/b/a AT&T Long Distance** (SBCLD or Applicant), located at **1010 N Saint Mary's Street, #13L, San Antonio, TX 78215**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue its provision of certain domestic telecommunications services in Ohio.

SBCLD indicates that it currently provides interstate residential and business local exchange service in Ohio. SBCLD explains that this service is basic telephone exchange service that allows customers to make local calls within a local exchange, which includes local calling areas that cross state boundary lines. SBCLD states that it plans to discontinue this service on or after October 1, 2007, subject to Commission authorization. SBCLD maintains that it currently does not have any customers that subscribe to the affected service, and that there are many alternative providers of local exchange telephone services in Ohio, including but not limited to Comcast Phone of Ohio, Level 3 Communications, ACN Communications, Inc., and Metropolitan Telecommunications of Ohio. Finally, SBCLD asserts that it is considered non-dominant with respect to the service to be discontinued.

In accordance with section 63.71(c) of the Commission's rules, SBCLD's application will be deemed to be granted automatically on the thirty-first (31st) day after the release date of this public notice, unless the Commission notifies SBCLD that the grant will not be automatically effective. In SBCLD's application, SBCLD indicates that it anticipates discontinuing service on or after October 1, 2007. Accordingly, pursuant to section 63.71(c) and the terms of SBCLD's application, absent further Commission action, SBCLD may terminate service in Ohio on **October 1, 2007**. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other

end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **September 17, 2007**. Such comments should refer to **WC Docket No. 07-190 and Comp. Pol. File No. 807**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail.
