**PLEADING CYCLE ESTABLISHED FOR COMMENTS ON
T-MOBILE USA, INC. AND SPRINT NEXTEL CORPORATION'S PETITION FOR
DECLARATORY RULING REGARDING NUMBER PORTABILITY**

Comments Due: February 8, 2007

1. On December 20, 2006, T-Mobile USA, Inc. and Sprint Nextel Corporation (collectively, Petitioners) filed a petition for declaratory ruling pursuant to section 1.2 of the Commission's rules.¹ Petitioners seek clarification of the number portability requirements the Commission promulgated pursuant to section 251(b)(2) of the Communications Act of 1934, as amended.² Specifically, Petitioners request that the Commission make clear that carriers obligated to provide number portability may not obstruct or delay the porting process by demanding information from requesting carriers beyond that required to validate the customer request and accomplish the port. Petitioners maintain that some carriers request excessive amounts of information as part of the porting process' creating significantly longer times for ports and a correspondingly higher number of cancellations of changes of service. Petitioners argue that this frustrates Congressional and Commission intent by discouraging competition.

This Public Notice establishes certain procedural requirements relating to consideration of Petitioners' petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented is generally required. See 47 C.F.R. § 1.1206(b). Other requirements pertaining to oral and written presentations are set forth in section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Interested parties may file comments on or before **February 8, 2007**, and reply comments on or before **February 23, 2007**. All filings should refer to **WC Docket No. 95-116**. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's

eRulemaking Portal, or (3) by filing paper copies. *See* Electronic Filing of Documents in Rulemaking Proceedings, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
 - For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number.
