**COMMENT SOUGHT ON A PETITION BY UNITED STATES CELLULAR CORPORATION  
FOR COMMISSION AGREEMENT IN REDEFINING THE SERVICE AREAS OF RURAL  
TELEPHONE COMPANIES IN THE STATE OF NEBRASKA**

The Wireline Competition Bureau seeks comment on a petition filed by United States Cellular Corporation, pursuant to section 54.207 of the Commission's rules, requesting the Commission's agreement with the decision of the Nebraska Public Service Commission (Nebraska Commission) to redefine the service areas of certain rural telephone companies in Nebraska at the wire center level.<sup>1</sup>

Section 54.207 of the Commission's rules, which implements section 214(e)(5) of the Communications Act of 1934, as amended, provides that a rural telephone company's service area will be its study area "unless and until the Commission and the states, after taking into account recommendations of a Federal-State Joint Board instituted under section 410(c) of the Act, establish a different definition of service area for such company."<sup>2</sup>

This is the Public Notice required by section 54.207(c)(2) of the Commission's rules.<sup>3</sup> If the Commission initiates a proceeding to consider the Petition, it must do so within 90 days of the release date of this Public Notice, pursuant to our rules.<sup>4</sup> If the Commission does not act on the Petition by **January 21, 2008**, the definition proposed by the Nebraska Commission will be deemed approved by the Commission and shall take effect in accordance with state procedures.<sup>5</sup>

Interested parties may file comments on or before **November 21, 2007**, and reply comments on or before **December 6, 2007**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>6</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>7</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>8</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>9</sup>
