**REPORT AND ORDER
(Proceeding Terminated)**

Adopted: October 31, 2007

Released: November 2, 2007

By the Assistant Chief, Audio Division, Media Bureau:

1. The Audio Division issued a *Notice of Proposed Rule Making* in response to a Petition for Rule Making filed by Laramie Mountain Broadcasting, LLC (“Petitioner”).¹ The *Notice* proposes the allotment of Channel 226C3 at Walden, Colorado, as potentially the community’s second local aural transmission service.² Petitioner filed an FCC Form 301 application proposing allotment of Channel 226C3 at Walden, Colorado, and was required to submit a filing fee.³

2. Petitioner filed comments supporting the allotment of Channel 226C3 at Walden, reaffirming its intention to apply for the channel if it is allotted and, if authorized, to build and operate a station on that channel. No other comments were received.

3. Walden is a community for allotment purposes and is deserving of a second local service. We find that the public interest would be served by the allotment of Channel 226C3 at Walden, Colorado. Channel 226C3 can be allotted at Walden with a site restriction of 20.6 km (12.8 miles) west of Walden. The reference coordinates for Channel 226C3 at Walden are: 40-42-01 NL and 106-31-21 WL.

4. The Commission will send a copy of this *Report and Order* in a report to be sent to Congress and the Government Accountability Office pursuant to the Congressional Review Act.⁴

5. Accordingly, IT IS ORDERED, That effective December 17, 2007, the FM Table of Allotments, 47 C.F.R. Section 73.202(b), IS AMENDED as follows:

7. A filing window period for Channel 226C3 at Walden, Colorado, will not be opened at this time. Instead, the issue of opening this allotment for auction will be addressed by the Commission in a subsequent *Order*.
