The Wireline Competition Bureau seeks comment on a petition filed by Texas RSA 8 South Limited Partnership d/b/a Westex Wireless seeking waiver of filing deadlines associated with the receipt of universal service funds, pursuant to sections 54.307(c)(2), 54.802(a), and 54.903(a) of the Commission's rules.<sup>1</sup>

Interested parties may file **comments on or before December 6, 2007** and **reply comments on or before December 21, 2007**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>2</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>3</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and

arguments presented generally is required.<sup>4</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>5</sup>
