COMMENT SOUGHT ON TRACFONE WIRELESS, INC.'S PETITIONS FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER IN THE STATES OF DELAWARE AND NEW HAMPSHIRE

The Wireline Competition Bureau seeks comment on two petitions filed by TracFone Wireless, Inc. (TracFone) on November 28, 2007, seeking designation as an eligible telecommunications carrier (ETC) in the states of Delaware and New Hampshire. TracFone seeks ETC designation pursuant to section 214(e)(6) of the Communications Act of 1934, as amended, throughout the entire states of both Delaware and New Hampshire, including both rural and non-rural telephone company service areas. TracFone seeks ETC designation solely to provide Lifeline service to qualifying customers in Delaware and New Hampshire, and it asserts that it will not seek federal universal service funds for the purpose of providing service to high-cost areas. The seeks are approximately assert to the purpose of providing service to high-cost areas.

Interested parties may file **comments on or before January 14, 2008** and **reply comments on or before January 29, 2008**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁴

These matters shall be treated as "permit-but-disclose" proceedings in accordance with the Commission's *ex parte* rules.⁵ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁶ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁷
