COMMENT SOUGHT ON ALLO COMMUNICATIONS' PETITION FOR WAIVER OF A FILING DEADLINE RELATED TO THE UNIVERSAL SERVICE PROGRAM

The Wireline Competition Bureau seeks comment on a petition filed by Allo Communications, seeking waiver of the September 28, 2007, filing deadline associated with the receipt of universal service funds pursuant to section 54.802 of the Commission's rules.¹

Interested parties may file **comments on or before January 25, 2008** and **reply comments on or before February 11, 2008**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.²

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: http://www.fcc.gov/cgb/ecfs/. Filers should follow the instructions provided on the website for submitting comments.

Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte*
