REQUEST OF CENTRAL TEXAS TELEPHONE COOPERATIVE, INC., FOR AUTHORITY TO INCLUDE IN ITS RATE BASE THE INTERSTATE PORTION OF THE PREPAID POST-EMPLOYMENT HEALTH BENEFITS RECORDED IN ACCOUNT 1410, OTHER NONCURRENT ASSETS

On January 17, 2007, Central Texas Telephone Cooperative, Inc. (Central Texas) filed a letter requesting authority to include in its rate base the interstate portion of the prepaid post-employment health benefits recorded in Account 1410, Other noncurrent assets. Central Texas uses a pre-funded trust for the retirement benefits, which has a pre-paid balance relating to post-retirement health benefits of \$163,173 as of December 31, 2005.

Interested parties may file comments on or before **February 20, 2007**, and reply comments on or before **March 2, 2007**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>2</sup> Comments filed through the ECFS can be sent as an electronic file via the Internet to <a href="http://www.fcc.gov/cgb/ecfs/">http://www.fcc.gov/cgb/ecfs/</a>. Generally, only one copy of an electronic submission must be filed.<sup>3</sup> In completing the transmittal screen, commenters should include their full

name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number, in this case WC Docket No. 07-20. Parties may also submit an electronic comment by Internet e-mail. A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. Parties are strongly encouraged to file comments electronically using the Commission's ECFS.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and
