**PLEADING CYCLE ESTABLISHED FOR COMMENTS  
ON MOTION TO DISMISS OR DENY  
VERIZON VIRGINIA BEACH PETITION FOR FORBEARANCE**

**WC Docket No. 08-49**

**Comments Due: May 19, 2008**  
**Reply Comments Due: May 27, 2008**

On April 29, 2008, Covad Communications Group *et al.* (CLEC Group) filed a “Motion to Dismiss or, in the Alternative, Deny Petition for Forbearance.”<sup>1</sup> In this Motion, the CLEC Group contends that Verizon has failed to make a *prima facie* case to justify a different outcome in the present proceeding than the Commission reached in the *Verizon 6 MSA Forbearance Order*.<sup>2</sup> Specifically, the CLEC Group claims that the facts presented in Verizon’s petition for forbearance in that portion of the Virginia Beach Metropolitan Statistical Area (MSA) where Cox is the incumbent cable operator<sup>3</sup> are a subset of the same facts upon which Verizon relied in support of its prior forbearance petition for the Virginia Beach MSA.<sup>4</sup> On December 4, 2007, the Commission unanimously denied Verizon’s petition for forbearance for the Virginia Beach MSA.<sup>5</sup> The CLEC Group contends that the Verizon Virginia Beach Petition therefore should be dismissed as facially insufficient, or summarily denied for failure to

meet the mandates of the Administrative Procedure Act, the Commission's rules and the forbearance standard of section 10 of the Communications Act of 1934, as amended.<sup>6</sup>

By this Public Notice, we seek comment on the substantive and procedural issues raised in the CLEC Motion to Dismiss. Interested parties may file comments on the CLEC Motion to Dismiss on or before **May 19, 2008** and reply comments on or before **May 27, 2008**. All pleadings should reference **WC Docket No. 08-49**.
