COMMENT SOUGHT ON FORT HEALTHCARE - FORT MEMORIAL HOSPITAL, FORT HEALTHCARE - LAKE MILLS CLINIC, FORT HEALTHCARE - WHITEWATER CLINIC, AND FRANCISCAN SKEMP WAUKON CLINIC'S REQUESTS FOR REVIEW OF DECISIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On May 15, 2008, Fort HealthCare—Fort Memorial Hospital, Fort HealthCare—Lake Mills Clinic, and Fort HealthCare—Whitewater Clinic, (collectively, Fort HealthCare) filed a request seeking review of decisions of the Universal Service Administrative Company (USAC), in which USAC denied Fort HealthCare's funding requests for Funding Year 2006 under the rural health care support mechanism.¹ In its request, Fort HealthCare asserts that USAC erroneously calculated the amount of funding due Fort HealthCare by doubling the proposed urban rates, which substantially reduced or eliminated Fort HealthCare's rural health care support.²

On May 15, 2008, Franciscan Skemp Waukon Clinic (Waukon Clinic) filed a request seeking review of a USAC decision in which USAC denied Waukon Clinic's funding request for Funding Years 2005 and 2006 under the rural health care support mechanism due to violations of the competitive bidding rules.³ In its request, Waukon Clinic asserts that it appropriately adhered to the "purpose of the competitive bidding requirement by ensuring that its contract...is competitively priced for the type of service rendered."⁴

Interested parties may file comments on or before **June 30, 2008**, and reply comments on or before **July 14, 2008**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.⁵
