## **Section 214 Application**

Applicants: Verizon California Inc., Verizon Delaware LLC, Verizon Maryland Inc., Verizon New Jersey Inc., Verizon North Inc., Verizon Norwest Inc., Verizon Pennsylvania Inc., Verizon Virginia Inc., Verizon Washington, D.C. Inc., and Verizon West Virginia Inc.

On May 5, 2008, Verizon California Inc., located at One GTE Place, Thousand Oaks, CA 91362-3811; Verizon Delaware LLC, located at 901 Tatnall St., Wilmington, DE 19801; Verizon Maryland Inc., located at 1 East Pratt St., Baltimore, MD 21202; Verizon New Jersey Inc., located at 540 Broad St., Newark, NJ 07102; Verizon New York Inc., located at 140 West St., New York, NY 10007; Verizon North Inc., located at 19845 N. U.S. 31, P.O. Box 407, Westfield, IN 46074; Verizon Northwest Inc., located at 1800 41st St., P.O. Box 1003, Everett, WA 98206; Verizon Pennsylvania Inc., located at 1717 Arch St., Philadelphia, PA 19103; Verizon Virginia Inc., located at 600 E. Main St., Richmond, VA 23219; Verizon Washington, D.C. Inc., located at 2055 L St., NW, 5th Floor, Washington, D.C. 20030; and Verizon West Virginia Inc., located at 1500 MacCorkle Ave., SE, Charleston, WV 25396 (collectively Verizon or Applicants), filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain domestic telecommunications services in Arizona, California, Connecticut, Delaware, the District of Columbia, Idaho, Illinois, Indiana, Maryland, Nevada, New Jersey, New York, Pennsylvania, Virginia, Washington, and West Virginia.

Verizon indicates that it provides Conference Service as (1) an interstate IntraLATA service in Arizona, California, Connecticut, Delaware, the District of Columbia, Maryland, Nevada, New York, Virginia, and West Virginia, (2) a "Corridor" service in the New York-New Jersey and New Jersey-Pennsylvania corridors, and (3) an interstate "IntraMarket" service in Idaho, Illinois, Indiana, and Washington (collectively Service Areas). Verizon explains that Conference Service allows customers to make conference calls between three or more points, one of which is in a different state from the call origination point, but within the same LATA, Corridor, or Market as the call origination point. Verizon states, however, that it currently does not have any customers for this service, and that it therefore intends

to discontinue Conference Service in the Service Areas on or after July 1, 2008, subject to Commission authorization. Verizon asserts that it is considered non-dominant with respect to the service to be discontinued.

In accordance with section 63.71(c) of the Commission's rules, Verizon's application will be deemed to be granted automatically on the 31st day after the release date of this public notice, unless the Commission notifies Verizon that the grant will not be automatically effective. In Verizon's application, Verizon indicates that it anticipates discontinuing service on or after July 1, 2008, subject to Commission authorization. Accordingly, pursuant to section 63.71(c) and the terms of Verizon's application, absent further Commission action, Verizon may discontinue its Conference Service in the Service Areas on or after July 1, 2008. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a "permit but disclose" proceeding for purposes of the Commission's ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **June 16, 2008**. Such comments should refer to **WC Docket No. 08-78 and Comp. Pol. File No. 866**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <a href="http://www.fcc.gov/cgb/ecfs/">http://www.fcc.gov/cgb/ecfs/</a>. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed.
