## COMMENT SOUGHT ON LAKE DELTON URGENT CARE AND FRANCISCAN SKEMP PRAIRIE DU CHIEN CLINIC'S REQUESTS FOR REVIEW OF DECISIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On May 28, 2008, Lake Delton Urgent Care and Franciscan Skemp Prairie du Chien Clinic (collectively, Petitioners) filed requests seeking review of decisions of the Universal Service Administrative Company (USAC), in which USAC denied Petitioner's funding requests for Funding Year 2006 under the rural health care support mechanism.<sup>1</sup> In the requests, Petitioners assert that USAC erroneously calculated the amount of funding due Petitioners by doubling the proposed urban rates, which substantially reduced petitioner's rural health care support.<sup>2</sup> In subsequent pleadings, Petitioners also request waiver of the 60-day filing deadline for review of USAC decisions.<sup>3</sup>

Interested parties may file comments on or before **July 10, 2008**, and reply comments on or before **July 25, 2008**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>
