COMMENT SOUGHT ON A PETITION FILED BY NORTHWEST IOWA TELEPHONE COMPANY FOR WAIVER OF SECTION 54.301(e)(1) OF THE COMMISSION'S RULES

The Wireline Competition Bureau seeks comment on a petition filed by Northwest Iowa Telephone Company seeking waiver of a filing deadline required by section 54.301(e)(1) of the Commission's rules for receipt of universal service funds.¹

Interested parties may file **comments on or before July 17, 2008** and **reply comments on or before August 1, 2008**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.²

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: http://www.fcc.gov/cgb/ecfs/. Filers should follow the instructions provided on the website for submitting comments.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte*
